Examination Procedures, Course Materials and Fees

Only Society members may file an exam application.

The Society is offering virtual online testing for the Fellow exam this year. This option is designed to alleviate possible testing obstacles and hardship you may encounter with onsite testing centres.

The filing fee is not refundable or transferable to another year or another individual. Course material fees are not refundable.



This exam qualifies for CEBS Compliance credit.

The combined course fully satisfies the 30 credits needed for this reporting cycle; the group benefits or retirement track each earns 15 credits.

The \$25 CE reporting fee does **not** apply to CEBS Compliance credits.

Canadian Examination and Course Materials

Canadian 2021 Fellowship Courses—Licensing and Professional Credit Information

Many members use the Society's Fellowship courses to meet licensing and other professional continuing education requirements. 2021 Course

Insurance CE Credit

ISCEBS recommends 30 credit hours per course/track in British Columbia, Nova Scotia, Ontario and Saskatchewan.

The 2021 courses will be submitted to the Alberta Insurance Council for preapproval. In 2020, the Alberta Insurance Council approved the ISCEBS CE Group Benefits course for 9 Accident & Sickness credits and 1 Adjuster credit and the Group Retirement course for 10 Life credits. The 2021 Fellow courses will be submitted to the Insurance Council of Manitoba for accreditation upon request. The Insurance Council of Manitoba approved the 2020 Fellowship Exam for the following credits: Group Benefits was approved for 30 Life and/or Accident & Sickness credits and Group Retirement was approved for 30 Life and/or Accident & Sickness credits.

Insurance agents from Alberta and Manitoba will receive a certificate of completion if requested at registration.

All other provinces accept the pass notice as proof of credit earned. Contact ISCEBS for reporting procedures.

Credit is not available in Quebec.

Registered Insurance Brokers of Ontario (RIBO)

The 2021 Fellow courses will be submitted to the Registered Insurance Brokers of Ontario (RIBO) for accreditation upon request. The 2020 ISCEBS CE Fellowship Course—Group Benefits was approved for 5 hours of Management credit. The 2020 ISCEBS CE Fellowship Course—Group Retirement was approved for 5 hours of Management credit. A certificate will be mailed upon completion if requested on the registration form.

On-Site Testing Option—Canada
