Mercer's survey includes private and public employers with 10 or more employees and is the largest and oldest of its kind.

Barry Schilmeister has been involved in insurance, benefits and actuarial work for over forty years, most of that time in group benefits consulting with Mercer. As an actuary and senior consultant, Mr. Schilmeister advises large employers on the strategic planning, structure, and financing of their group benefit programs, focused largely on health care. He has spoken on a variety of healthcare benefit topics to many area human resources and health care industry groups and has provided insights to a number of media outlets such as the New York Times, the Wall Street Journal, CNBC, Business Week TV, and Crain's New York Business.

Mr. Schilmeister is the New York area health and benefits lead for Mercer's Healthcare Industry Vertical, which brings together the intellectual capital of Mercer's national network of consultants to the health care industry. He is the New York spokesperson for Mercer's National Survey of Employer-Sponsored Health Plans, leading seminars each year across the tri-state area.
